3. Extra charge applies for existing floor repair, patch up, and leveling, unless stated in the quote.
4. There might be unavoidable scratches on the wall and skirting caused by the installer's tools or new flooring during installation. Any claims against such issues will not be compensated.
5. Sometimes there might be gaps between the new skirting and wall, or scotia and wall if the wall is not straight. Vista Floors do not take any responsibility for such issues.
6. Dust may be generated when cutting floorboards, sanding, or removing old carpet. Please cover the furniture or any appliance that you do not want the dust to fall on, otherwise, the installers will not clean it.
7. All our floating floor comes with 20 years limited manufacturer warranty, carpet with 3 to 25 years limited manufacturer warranty. All our installation work comes with a one-year limited warranty.
8. Scratches, dents, other incidental damages, or normal wear and tear after installation are not covered by our warranty.
9. Any type of water damage on carpet, laminate, or any other timber flooring is not covered by the warranty. In circumstances such as site flooding, extended water submersion, or leakage, all the flooring will not be covered by the warranty.
